## AND ACCOMODATION FOR CLASS ROOMS: -

Total built up area as per the strength of the school is required 1866 Sq feet, whereas the school buildings built up area is about 21,096 Sq. feet out of which 14, 197 Sq.feet is available for accommodation for Class Rooms, which is sufficient.

## PLAYING AREA:

The Upper Primary/Secondary schools must have Outdoor/indoor playing area basing on the Enrollment range as per the G.O.Ms.No. 88 Edn., (SE-PS-1) Dated: 07-07-2008. The school is providing 402 Sq.meters outdoor playing area and also providing 641 Sq. meters of indoor playing area, total 1043 Sq.meters of playing area, which is sufficient.

As per the G.O.Ms. No. 86 M.A. & U.D. (M1) Dept. Dated: 03-03-2006, the parking area should be 30%., of total built up area. So the required parking place is 588 Sq meters. The school is providing 616 Sq meters parking area is available, which is sufficient.

Therefore, it is RECOMMENDED from traffic point of view in respect of Pallavi Model School, Premises GLR Sy. No. 303, 304, Trimulgherry, Sec-bad with a condition to allow the parents/guardian vehicles inside the premises of the School.
